



## **INFORMATION FOR CUSTOMERS (DEALERS AND SERVICE POINTS) IN RELATION WITH THE PROCESSING OF PERSONAL DATA**

*Pursuant to art. 13 of General Regulation about the protection of personal data (RGPD 2016/679)*

According with the art. 13 of Regulation UE 2016/679 the KATO IMER Spa company, holder of processing of personal data, gives you the following information in relation with the processing of data referred to the natural people.

### **Purposes and judicial basis of processing**

The personal data of clients/dealers, of natural people or that represent the legal subject and eventually those of their employees (name and surname, function/job, e-mail and number of company tel.) are used for:

- The distribution of proposals or satisfy its other pre-contractual requests;
- The distribution of related foreseen services in the execution of contractual agreements
- The fulfilment of eventual law and/or regulation obligation (ex. Invoicing, accounting bookkeeping);
- The protection of Company rights, therefore of a legitimate interest of the holder, both in legal or extrajudicial branch;

The interested party can deny to confer to the Holder his personal data for the purposes, ascribed at previous points; the provision of personal data is, however, necessary for a correct and efficient management of contractual relationship. Therefore, an eventual deny to give his data can compromise totally or partially the contractual relationship in the same way.

We inform you, as our Assistance center dealer, being part of our network, that we will use some of your data for the following purposes unless you deny such activity, by signing the form that you will find at the end of this document:

- Send you promotional documents related to products and services that have relevance with our relationship;
- Publishing your contact data on our website in the sections Sales network and Service network by putting at disposal the contents in the RESERVED AREA to which you can accede by means an authentication procedure (Id and password).



For this purpose, your deny does not affect the continuation of our relationship, however could influence it, by complicating some aspects of it, like for example our communications. We remind you that you further can annul anytime your authorization with a written communication made towards the holder.

### **Way of Processing**

The data processing will take place by means the use of tools and procedures, fit to guarantee the safety and the confidentiality; and can be made by means both paper means and electronic tools.

### **Area of processing and communication of data**

The personal data will be processed by our personnel who is authorized to processing and by our consultants, within given limits to carry out their professional task on behalf of our company, individuuated as responsible of processing. For a complete list of responsible of data processing you can contact any time the holder at contact number or e-mail that are at disposal below. Your data will be not “disseminated”, that is to say, they do not get know by indeterminate subjects; they can, instead, be “communicated” by us to subjects, public or private, that can accede to data in force of law dispositions or regulation and in the limits imposed by them.

### **Transfer of personal data to third countries or International organizations**

No data is transferred towards countries that do not belong to UE or to International organizations.

### **Automated processing**

The company does not carry out a processing based on a automated decisional process, including the profiling that produce judicial effects towards you or that can affect significantly on your person.

### **Times of data storage**

The data will be processed during all the duration of the established contractual relationships and later for the fulfilment of all law compliance. The data will be stored in our archive according with the following parameters:

For financial, accounting, contractual activities, Management of an eventual controversy from 5 to 10 years as established by law of Civil normative and by the rules that set the powers and the checking operation in the fiscal field, excepting eventual and specific reasons that justify the extension (ex. in case of controversy or ascertainment made by competent authorities).



We will send you promotional messages by e-mail till when you deny such way, by using anytime and in the ways, previously illustrated, your cancellation right.

### **Rights of interested party**

As interested party, natural person, you can argue your rights pursuant art. from 15 to 21 of RGPD 2016/679, here synthetically written, by asking anytime for the holder. Specifically you can accede to personal data that concern you, by obtaining the correction or the cancellation of them, the limitation of processing, the portability of data or opposing to the processing.

### **Right of complaint**

The interested parties who think that the processing of personal data referred to them are in violation with what foreseen by the Regulation, have the right to make a claim to the Guarantor, according with the art. 77 of Regulation, or to appeal the opportune judicial branches (art. 79 of Regulation).
